

REVIEWING DECISIONS OF 26TH STEVTA BOARD OF GOVERNORS MEETING

IN CONTINUATION TO 26TH MEETING OF STEVTA BOARD OF GOVERNORS (BOG) MEETING HELD ON 18TH MARCH, 2020

STEVTA Headquarters: Karachi Working Papers For Reviewing Decisions of 26¹¹ STEVTA BOARD OF GOVERNORS MEETING BACKGROUND: Sindh TEVTA was established by Government of Sindh through STEVTA Act, 2009 as an autonomous organization under its control. All general directions, matters of policy and affairs of Authority are vested in Board, except certain powers which are entrusted to Government, specifically. Like appointment of STEVTA Board members under Section 5 of STEVTA Act, framing rules under Section 2 and appointment of Managing Director under Section 8 of the Act as reproduced below:

- "(1) There shall be a full-time Managing Director of the Authority <u>appointed by the Government on such terms and conditions</u> as it may determine.
- (2) The <u>Managing Director shall be an eminent professional of known integrity and competence having experience of public or private sector management</u> especially in the context of managing human resources, financial management, and program implementation and may additionally have technical understanding of demands of industry and market in terms of manpower skills and competence.
- (3) The <u>Managing Director shall be paid such salary and allowances as may be determined by the Government</u> but his salary and allowances shall not be varied to his disadvantage during the term of his office.
- (4) The Managing Director shall have a term of three years"

Accordingly, the Government of Sindh was pleased to appoint Agha Sohail Ahmed an officer of Ex-PCS BS-19 as Managing Director STEVTA vide notification No. SOI/(SGA&CD)-3/03/2016 dated: 23/6/2020 being an eminent professional of known integrity and competence. Brief service profile of Mr. Agha Sohail Ahmed is as under:

"He possesses Masters in Public Policy from London School of Economics, United Kingdom. He remained posted on various important positions like Chairman Sindh Textbook Board, Member Chief Minister's Inspection Team, DC Jamshoro in addition to holding other important assignments. He has vast experience in the field of human resource management, financial management, education, training and industrial management etc."

It is worth to mention that no pay & scale is mentioned / assigned to the post of Managing Director, STEVTA under STEVTA Act. However, mentioning pay & scale by STEVTA Board in different decision is repugnant to STEVTA Act and creates anomaly in implementation of those decisions like fixation of pay & package of present incumbent etc. as decided by Board, in its 26th meeting held on 18th March, 2020.

Therefore, it is proposed that pay & scale mentioned against the post of Managing Director under / in any decision of STEVTA Board may be deleted ab-initio. Accordingly, the following decisions taken by STEVTA Board in its 26th meeting may please be reviewed to make those decisions in consonance with STEVTA Act: (STEVTA Act and minutes of 26th BoG flagged as F/A and F/B)
