Subject: - **FINAL SHOW CAUSE NOTICE**

In exercise of powers conferred by Rule 4-A read with sub-rule-3 of Rule-5 of the Sindh Civil Servants (Efficiency and Discipline) Rule, 1973, I, **Dr. Shereen Mustafa**, Managing Director STEVTA, Karachi being authorized officer:-

- am of the opinion that in view of the allegations that is guilty of misconduct, as per details given below, there are sufficient grounds that disciplinary action be taken against you under the said rules and
- have decided that it is not necessary to have enquiry conducted through an Enquiry Officer or Enquiry Committee.

2. I, therefore, by this notice inform that such attitude towards your duty is considered as '**Misconduct**' on the below mentioned grounds & it is proposed to impose the penalties described in Rule 4 of supra mentioned rules which may include major penalty of dismissal from service. You are accordingly called upon to Show Cause why the proposed action should not be taken against you.

3. The details of misconduct on your part are as under:-  
**"It has been reported that you are unauthorized absent from Government duty since 31-05-2022. For the same; explanations by the Principal GCT (B) SITE Karachi dated 30-11-2022 and 28-02-2023 had already been called to explain your position and directed to resume your duty but you failed to comply the directives."**

4. Your reply should reach the undersigned within 07 days of the receipt of this notice, failing which, exparte decision will be taken against you under the Sindh Civil Servants (Efficiency and Discipline) Rules 1973. You may also indicate whether you would like to be heard in person.
