

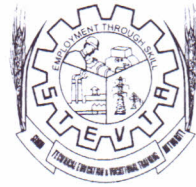

Sindh Technical Education & Vocational Training Authority (STEVTA) on approval new ADP schemes invites sealed bids on single stage two envelop procedure under provision of SPPRA Rules-47 2010 (Amended in 2018) to complete the Establishment and Up-Gradation schemes. The Tenders may be obtained from the date of publication of this advertisement in Newspapers / Website of SPPRA and STEVTA by an interested eligible firms registered with PEC in relevant category with specialization CE10, EE11(i) and ME01 on submission of a written application addressed to the Deputy Director (Works & Services) upon payment of a non refundable fee Rs.2,000/= in shape of pay order in the name of Sindh Technical Education & Vocational Training Authority (STEVTA) up to **16-12-2019** during office hours and the bids shall be single stage two separate envelops.  - Registration certificates of Income Tax (FBR) & Sales Tax / Sindh Revenue Board along tax returns of last three years.
 - Documentary evidence / Work orders of minimum last 03 years having similar nature of works completed within last three years with satisfactory completion certificates.
 - Bank statement along with financial transaction of last three years. Firm must have three times more turnover than estimated cost.
 - For Financial status assessment, the firm is required to submit Audited Financial statement by the chartered accountant firm of last three years.
 - Complete Company / Firm Profile with detail of projects of similar nature, list of employees and equipments. Complete detail of machinery on judicial Stamp paper duly attested by the notary public.
 - Affidavit of the contractors / firms that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government / Private organization.
