



### STANDARD OPERATING PROCEDURE (SOP) Admissions in 3-Years DAE Programme

Academic Session 2016-17

### A. ANNOUNCEMENT OF ADMISSIONS

Admissions for the 3-Years DAE Academic Session 2016-17 will be announced on <u>Sunday</u>, <u>August 07, 2016</u> through local newspapers of English, Urdu and Sindhi.

### **B. OPEN HOUSE WEEK**

- i. All institutions offering 3-Years DAE programme shall remain open from <u>August 08 -</u> <u>August 13, 2016</u> to welcome prospective Candidates and/or their Parents / Guardian for visiting facilities at the institutions and seek guidance for Admission.
- ii. The Head of Institute shall put on display various projects made by past and current students to inspire and motivate prospective Candidates and/or their Parents / Guardian to seek admission in Sindh TEVTA institutes.
- iii. The Head of Institute shall put on display the following helpline numbers and website in all prominent places in the institute and on the Admission Help Desk:

### C. ADMISSION PROCEDURE

- i. Candidate shall obtain and submit Admission Forms from <u>August 15 September 10,</u> <u>2016</u> during institute office timing (8:00 AM – 2:00 PM) from any Sindh TEVTA institutes offering 3-Years DAE programme.
- ii. Candidate shall obtain the Admission Package (including Prospectus, Admission Form, NTS Pre-Admission Entry Test Registration Form, Deposit slip, Return Envelope) on cash payment of **Rs. 600/-** from the Institute only. The Admission Form, NTS Pre-Admission Entry Test Registration Form and Deposit slip (in each Admission Package) will bear a same unique number, which will be used for reference in future. However, the Deposit slip will not be entertained / considered as a Pre-Admission Entry Test Admit card.

- iii. The Registrar will maintain an official register (Academic Session 2016-17) and make a record of each Admission pack sold & receiving of payments and submit for Audit in both hardcopy and Electronic format.
- iv. The Registrar is responsible for issuing the Admission pack and receiving the Admission Form, NTS Pre-Admission Entry Test Registration Form and required documents. On receipt of **Rs. 600/-**, the Registrar will ensure:

### 1) DAE Admission Form

- a) All mandatory entries are filled in the Admission Form.
- b) One photograph is affixed on the Admission Form.
- c) The Admission Form is duly attested and stamped by the Registrar.
- d) The Undertaking is provided on a judicial bond / stamp paper of Rs.20/- and duly attested by a First Class Magistrate (in compliance with the orders of the Supreme Court of Pakistan in Human Rights case, 1992).

### 2) NTS Pre-Admission Entry Test Registration Form

- a) All mandatory entries are filled in the NTS Pre-Admission Entry Test Registration Form.
- b) Two photographs are affixed on the NTS Pre-Admission Entry Test Registration Form.
- c) The NTS Pre-Admission Entry Test Registration Form is duly verified and stamped by the Registrar.

### 3) Deposit Slip

- a) Fill in Complete Details (i.e. Form No, Current Date, Institute Name, Candidate's Name, Father's Name and CNIC # / B-Form #) on both the Candidate Copy and Institute Copy of the Deposit slip.
- b) Ensure that the Candidate verify the information before signing the both copies of the Deposit slip.
- c) Sign and stamp with the official Institute stamp on the designated space on the Deposit Slip.
- d) Put an entry in the Official DAE Admission Academic Session 2016-17 register and Candidate signs it accordingly.
- e) Retain the Institute copy of the Deposit slip.
- f) Issue Candidate copy to the Candidate.
- v. At the time of submission of Admission Form and NTS Pre-Admission Entry Test Registration form by the Candidate, the Registrar is responsible to verify the desired Documents and Forms.
- vi. The Head of Institute shall forward to NTS the (1) NTS Pre-Admission Entry Test Registration form, (2) Detailed list of Candidates (containing Candidate Name, Father's Name, CNIC / B-Form, Contact Number, Deposit slip number), and (3) Bank Pay order for the amount of Admission Package sold (@ **Rs. 600/-** per package) sold to the following address:

xii. In the case of any discrepancies, the Head of Institute is responsible to inform the Focal Person immediately by official letter and in electronic copy.

### D. PRE-ADMISSION ENTRY TEST BY NTS

- i. Pre-admission entry test will be conducted by National Testing Services (NTS) and shall be compulsory for all candidates applying for any of the DAE programme (i.e. MRP / DSP / SSHBP / SHBEP). Passing NTS test is mandatory, minimum 20% marks are required to pass the NTS test. The NTS Test will be given 40% weight age in preparation of merit.
- ii. The Admit Card for Pre-admission Test shall be issued and dispatched to the Candidate by NTS via courier service at the postal address mentioned by the Candidate in the Admission form. Additionally, the Admit Card will also be available for download from NTS website (www.nts.org.pk). Further NTS will provide duplicate copy of Admit Cards to the Head of Institute of concerned Institute. Entry into Pre-Admission Test shall not be allowed without Admit Card.
- iii. <u>The Candidate shall make sure that his/her address and contact details mentioned on the</u> <u>Admission Form and NTS Pre-Admission Entry Test Registration form is correct and up to</u> <u>date. The Institute or NTS will not be responsible for any wrong/incorrect information</u> <u>provided by the Candidate</u>.
- iv. If the Candidate does not receive Admit Card 05 days before the test date the Candidate is advised to contact the respective Head of Institute.

### E. PROCEDURE FOR ADMISSION AGAINST RESERVED SEATS

- i. Candidates seeking admission on seats reserved for Other Provinces, Azad Kashmir / Northern Areas / FATA / Makran Division (Baluchistan) / Children of Defence Personnel must apply through respective Technical Vocational Education Authority (TEVTA) Headquarters / Section Officer (Estate & F.R. Division), Govt. of Pakistan / Secretary (Nomination Board) Muzafarabad, Azad Kashmir / Concerned Defence Headquarters to the Director (Academics & Training) Sindh TEVTA HQ.
- ii. Candidates applying on the quota for (1) Real Sons / Daughters / Sisters / Brothers of the employees of Sindh TEVTA, or (2) Employees of Sindh TEVTA, or (3) Employees of Sindh Board of Technical Education (SBTE) shall submit on the proscribed proforma as the per following schedule:

- iii. The Candidates shall then be called for interview by the DAE Reserved Seat Admission Committee at Sindh TEVTA HQ / Regional Directorate, for selection on Merit for admission in desired Institute and Technology.
- iv. As per Sindh TEVTA Admission policy, all Reserved Seats Candidates are exempted from NTS Pre-admission Entry Test.

### F. PROCEDURE FOR UP-GRADATION OF CANDIDATES

- i. After last date for deposit of fee for 1<sup>st</sup> Merit List on <u>October 15, 2016</u>, the successful Candidates will be adjusted / upgraded as per their choice / preference of technology on Merit by the Institute.
- ii. After adjustment / up-gradation of admitted Candidates, if there are any vacant seats available, the Institute will forward the data to the concerned Regional Directorate and forward an electronic copy to the Director (A&T), Sindh TEVTA HQ, Karachi by <u>October</u> <u>15, 2016</u>.
- iii. The remaining Candidates who are not offered admission shall be required to submit "Request Form" in the respective Institutes where they had originally applied for admission. The data of Request Forms shall be forwarded by the Institutes to the concerned Regional Director. The Regional Director shall consider the Claim cases against vacant seats and forward its adjustment proposals to the respective Institutes by <u>October 19, 2016</u>.
- iv. Institute will seek approval for up-gradation of Candidates from the concerned Regional Director only.
- v. After closing of the admission process on <u>October 20, 2016</u>, the Regional Director will forward the complete Admission data of Academic Session 2016-17 by <u>October 21, 2016</u>, in electronic format, in the format prescribed by to Director (A&T) at Sindh TEVTA HQ Karachi, for maintaining and updating the Student Database.
- vi. The Final Merit List will be forwarded to the Director (A&T) for uploading on the Sindh TEVTA website by <u>October 24, 2016</u>.
- vii. Provisional selection of Candidates will be subject to verification of Documents from concerned Board of Education or certificate issuing authority by the Candidate. However, Rs. 300/- will be paid by Candidate at the time of admission for Document Scrutiny fee / services provided by Institute / Regional Directorate / A&T Department, Sindh TEVTA HQ.

### G. ROLE & RESPONSIBILITIES

### NATIONAL TESTING SERVICE PAKISTAN

i. The printing and distribution of Admission Package to the institute will be undertaken by NTS.

- NTS will launch a Social Media Campaign (e.g. SMS, Newspaper WhatsApp groups, NTS Facebook groups) for Admission into the 3-Years DAE Academic session 2016-17.
- iii. NTS will develop the student database for the preparation of the Merit lists after the test.
- iv. NTS will develop the NTS Pre-Admission Entry Test Admit Card (i.e. Roll No, Candidate Personnel information, Photograph and information about the NTS Pre-Admission Entry Test date, time, and venue.
- v. The said Admit Cards will be dispatched to Candidates on their postal address and will be available on the NTS website.
- vi. NTS will arrange the Pre-Admission Entry Test venue and make necessary arrangements at the place of Test including complete covered seating arrangements, security, and clean drinking water for Candidates.
- vii. NTS will hand over the Pre-Admission Entry Test result (NTS score marks only) to the Focal Person within 05 (Five) days after the Test date and upload the same on NTS web site.
- viii. NTS will hand over the Merit List within 15 (Fifteen) days after the test date and upload the same on NTS web site.

### SINDH TEVTA

### a) <u>A&T DEPARTMENT, SINDH TEVTA HQ</u>

- i. The A&T Department is responsible for the complete Admission activities in Sindh TEVTA.
- ii. The Director (A&T) will approve and submit the Admission Notice to be advertised in leading and local Newspapers (i.e. English, Urdu, and Sindhi).
- iii. The Director (A&T) shall designate a Focal Person who will liaison between the Sindh TEVTA and NTS.
- iv. The Focal Person will forward the Institute-wise requirement of the Admission Package to NTS, after receiving the requisition from the Regional Directorates one month prior to start of Admission activities.
- v. The Director (A&T) shall approve and notify the list of Sindh TEVTA Officers to assist NTS at Test centres before the conduct of the Pre-Admission Entry test @ two officers per centre.
- vi. The Director (A&T) shall notify the vigilance committees for NTS Pre-admission Entry Test in all for each test centre.

vii. Sindh TEVTA will display the 1<sup>st</sup> Merit List through its website on <u>October 08, 2016</u>. The 2<sup>nd</sup> Merit List by <u>October 17, 2016</u>. And the Final Merit List on <u>October 24, 2016</u>.

### b) <u>REGIONAL DIRECTORATE</u>

- i. The Regional Directorate is responsible for all Admission activities at the regional level.
- ii. The Regional Director will provide up-to-date admission updates to the Focal Person on the first day of every week by electronic format only.
- iii. The Regional Directorate will support the Institute in any and all of their query.
- iv. The Regional Director is responsible for issuance of Age relaxation certificate (from 2 years up to 7 years only) for prospective Candidate after completing all codal formalities.
- v. The Regional Director will notify the Regional Directorate Admission team to deal with all Admission related queries on the regional level.

### c) <u>INSTITUTE</u>

- i. The Institute is responsible for all Admission activities at the Institute level and will report to the Regional Director on all admission related matters.
- ii. Admission activities such as, but not limited to:
  - a. Providing the Academic Package requisition data to the Regional Director, at least one month before the start of Admission activities.
  - b. Organizing the Admission media campaign within the vicinity of the institute, be it independent or in collaboration of other nearby Sindh TEVTA institutes.
  - c. Posting of Admission notices in and nearby vicinity of the institute.
  - d. Organizing the Open House week in the institute.
  - e. Setting up an Admission Help Desk for dealing with prospective Candidates and / or their Parents / Guarding queries and issues.
  - f. Ensuring that adequate security arrangements have been made in the institute for the safety of all staff, students and visitors during the admission process and commencing of classes.
  - g. Issuing Age relaxation certificate (up to 2 years only) for prospective Candidate after completing all codal formalities.
  - h. The requisition, receiving and dispatching of the Academic Package is the responsibility of the Head of Institute only.
- iii. The Registrar is responsible for the issuance of Admission Package and recording each sale in the official DAE Academic Session 2016-17 register.
