- The bids will be opened on the aforementioned date & time in the presence of bidders or their authorized representatives. Prospective bidders are invited to attend the tender opening (single representation).
- Incomplete tenders cannot be considered or entertained. (Kindly Read carefully & completely fill up the document and attach all required documents)
- Submit one original technical proposal and one original financial proposal. The proposal shall be in book binding form, properly page numbered (Loose, Ring and spiral binding shall not acceptable). Each proposal shall be in a separate envelope as appropriate. The technical proposal shall be placed in an envelope clearly marked "Technical Proposal" and the financial proposal in the one marked "Financial Proposal". These two envelopes, in turn, shall be sealed in an outer envelope bearing the address and information indicated in the Data Sheet. A damaged / torn financial proposal envelope shall not be entertained and may be considered fordisqualification by the procurement committee
