SUBJECT: SHOW CAUSE NOTICE.

In exercise of the powers conferred by Rule 4-A with sub-rule-3 of Rule-5 of the Sindh Civil Servant (Efficiency and Discipline) Rules, 1973. I, **Mr. Munwar Ali Mithani**, Managing Director, STEVTA, Karachi, being authorized officer:-

- A) Am of the opinion that in view of the allegations that is guilty of misconduct, as per details given below, there are sufficient grounds that disciplinary action be taken against you under the said Rules.
- 02. The details of your misconduct are as under:-

"It has been reported by the Principal, Govt. Saifee Eide Zahabi College of Technology, camp at GPI, (W), North Nazimabad, Karachi that you have been un-authorized absent from Government duty since April-2013 without any intimation or permission, which is an act of misconduct on your part and against the norms of services discipline.

- 03. I, therefore, by this notice inform that such attitude towards your duty is considered as "Misconduct" on the above mentioned grounds & it is proposed to impose the penalties described in Rule 4 of supra mentioned rules which may include major penalty of dismissal from services. You are accordingly called upon to Show Cause why the proposed action should not be taken against you.
- O4. Your explanation should reach the undersigned within 14 days of the receipt of this notice, failing which, exparte decision will be taken against you under the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973. You may also indicated whether you would like to be heard in person.
