- (iv) For Financial status assessment, the firm is required to submit Bank statement along with financial transaction of last three years / Audited Financial statement by the chartered accountant firm of last three years.
- (v) Complete Company / Firm Profile with detail of projects of similar nature, Works in hand, list of employees and equipments / machinery.
- Affidavit of the contractor / firm that firm is not involved in any litigation / Departmental rift / abandoned or unnecessary delay in completion of any work in the Government / Private organization and all documents / Particulars / information furnished / submitted are true and correct on E-Stamp Only. If any information found incorrect / misleading the procuring agency reserve the right to reject the firm / Company.
- (vii) Physical presentation of the professional staff and other original documents as deemed by the prequalification / procurement committee will be the responsibility of the applicant as and when requested. In the case of failure the firm/ Company will not considered for prequalification.
- (viii) General Experience: Minimum five (5) years to be reckoned with effect from registration date.
- (ix) Average Annual Financial Turnover: Minimum PKR: 50 million in last (3) years.
- (x) Evaluation Criteria, Sub-criteria, for the evaluation of full Technical Proposals is based on Yes/No OR Pass/Fail, if a bidder fails to obtain yes or pass in any criteria or sub-criteria then he / it shall not be qualified.
- (xi) Each page of Technical Proposal / Brusher must be numbered and attested by the owner of the firm / company along with its stamp.
- (xii) Presentation on the design proposal will be required from the firm.
