- iii. I shall treat all members of the management, faculty, staff, and fellow students with dignity and respect at all times.
I shall refrain from making any statement or performing any act, gesture, or behaviour that promotes hatred, discrimination, or disrespect based on sect, religion, ethnicity, caste, gender, nationality, or place of origin, whether in Pakistan or China.
- iv. I shall actively protect and preserve the property and assets of both the STEVTA and Chinese institutes and shall take reasonable steps to prevent any damage, misuse, or destruction.
- v. I shall follow the decisions and instructions of the concerned faculty, management, and any discipline or administrative committee constituted to maintain institutional order.
- vi. I undertake to pay all tuition fees and administrative charges on time. I understand that failure to do so may result in late fines, disciplinary action, or removal from the programme.
