ORDER

WHEREAS, Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant, Sindh TEVTA was issued show-cause notice on account of **Dual Job** at STEVTA and Child Care Worker at Social Welfare Department vide this office letter No. STEVTA/HQ/HR/PF-29/1227 dated; 22-03-2024, in exercise of the powers conferred by Rule 4-A read with Sub Rule (3) of rule 5 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973.

AND WHEREAS, Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant, did not respond to the same, accordingly **final show cause** notice issued vide this office letter No. STEVTA/HQ/HR/PF-29/2011 dated; 16-05-2024, in exercise of the powers conferred by Rule 4-A read with Sub Rule (3) of rule 5 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973.

AND WHEREAS, Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant, also did not respond to the Final Show Cause, accordingly the same has been published in widely circulated news paper i.e. Kawaish vide dated 12-06-2024.

AND WHEREAS, Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant, submitted his resignation on 01-07-2024, where he sated that "*due to unavoidable circumstances, I hereby submit my resignation and cannot be able to continue further my services with immediate effect.*"

AND NOW WHEREAS, the charges mentioned in the said Show Cause Notice have been proved against Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant, and he has failed to show reasonable cause for not imposing a major/minor penalty under rule 4 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973.

NOW THEREFORE, The competent Authority i.e I, **Munawar Ali Mithani**, Managing Director, Sindh TEVTA, Karachi being authorized officer do hereby impose a **major penalty** of "**DISMISSAL FROM SERVICES**" under rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973 upon accused Mr. Muhammad Faran Khan, Cashier (BS-06), Public Servant.
