- Bid opening procedure will be based on Single Stage Two Envelopes System (bid shall comprise a single package containing two separate envelopes inside). One envelope shall contain Technical Proposal containing complete material specifications, company profile, NTN and GST Certificate of the company or any other information required in deemed necessary, whereas the other envelop shall contain the financial bid. The envelopes should clearly mark as "Technical Proposal" and "Financial Proposal" in bold legible letters. Initially only Technical Proposals shall be opened.
- The bids will be opened on the aforementioned date & time in the presence of bidders or their authorized representatives. Prospective bidders are invited to attend the tender opening (single representation).
- The tender name and package (applied for) should clearly be written / marked on envelope.
