- Sealed bids with necessary attachments accompanied by the Bid Security should be submitted/dropped in Tender Box, marked “**PROCUREMENT**” & **(TENDER TITLE)** at Sindh Technical Education & Vocational Training Authority, Street-19, Block-6, Gulshan-e-Iqbal, Near NIPA Chowrangi, Karachi, on the tender document submission date and time.
- The bids will be opened on the aforementioned date & time in the presence of bidders or their authorized representatives.
- **Incomplete tenders cannot be considered or entertained.** (Kindly Read carefully & completely fill up the document and attach all required documents, as required for eligibility criteria)
- Submit one original technical proposal and one original financial proposal. The proposal shall be in book binding form, properly page numbered (**Loose, Ring and spiral binding shall not acceptable**). Each proposal shall be in a separate envelope as appropriate. The technical proposal shall be placed in an envelope clearly marked “**Technical Proposal**” and the financial proposal in the one marked “**Financial Proposal**”. These two envelopes, in turn, shall be sealed in an outer envelope bearing the address and information indicated in the Data Sheet. A damaged / torn financial proposal envelope shall not be entertained and may be considered for disqualification by the procurement committee.
- STEVTA reserves the right to accept or reject any bid, subject to relevant provisions of Sindh Public Procurement Rules, 2010 (amended 2019).
