SUBJECT: **FINAL SHOW CAUSE NOTICE**

In exercise of the powers conferred by Rule 4-A read with Sub Rule (3) of rule 5 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973, I **Dr. Mustafa Suhag**, Managing Director, Sindh TEVTA, Karachi being authorized officer:-

- a) am of the opinion that in view of the allegations that is guilty of misconduct, as per details given below, there are sufficient grounds that disciplinary action be taken against you under the said Rules and
- b) *Have decided that it is not necessary to have enquiry conducted through an Enquiry Officer or Enquiry Committee.*

2. I, therefore, by this Notice inform you that such attitude towards your duty is considered as 'misconduct' on the below mentioned grounds & it is proposed to impose the penalties described in Rule 4 of the above cited Rules which may include major penalty of dismissal from service. You are accordingly called upon to Final Show Cause that why the proposed action should not be taken against you.

3. Your explanation (in duplicate) should reach the under signed within 14 days of the receipt of this Notice failing which ex parte decision will be taken against you under the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973. You may also indicate whether you would like to be heard in person.

4. The details of your misconduct are as under:

"It has been reported that you are continuously absent from Government duty since 29.09.2017 without obtaining approval of leave despite the fact that you have communicated vide a letter of this office dated 07.11.2017 that your request for grant of 02 years extra ordinary leave has been regretted by the competent authority i-e Managing Director, Sindh TEVTA, also directed to resume your duty without any further delay.

For the same an explanation dated 22-03-2018 had already been called to explain your position and directed to resume your duty but regretted to state that you found failed to comply the directives."
