ORDER

WHEREAS, Mr. Ghulam Mustafa Chandio, Security Guard (BS-02), Public Servant, Sindh TEVTA was issued **Show-Cause Notice** on account of **Dual Job at STEVTA** and District Population Welfare Department, Govt. of Sindh, vide this office letter No. STEVTA/HQ/HR/PF-101/1224/2023-24/Karachi, dated: 22-03-2024 in exercise of the powers conferred by Rule 4-A read with Sub-Rule (3) of rule 5 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973.

AND WHEREAS, Mr. Ghulam Mustafa Chandio, Security Guard (BS-02), Public Servant, did not respond to the same, accordingly **Final Show Cause Notice** issued vide this office letter No. STEVTA/HQ/HR/PF-101/2012/2023-24/Karachi, dated: 16-05-2024 in exercise of the powers conferred by Rule 4-A read with Sub Rule (3) of rule 5 of the Sindh Civil Servants ((Efficiency and Discipline) Rules, 1973.

AND WHEREAS, Mr. Ghulam Mustafa Chandio, Security Guard (BS-02), Public Servant, submitted his resignation on 24-07-2024, where he stated that *“due to his domestic affairs and I am not in position to continue my services and my resignation may kindly be accepted with effect from 01-07-2024”*, which had not been entertained.

AND WHEREAS, the Final Show Cause Notice of Mr. Ghulam Mustafa Chandio, Security Guard (BS-02), Public Servant has been published in widely circulated newspaper i.e. Kawish vide dated 04-10-2024.

AND NOW WHEREAS, the charges mentioned in the said Show Cause Notice have been proved against Mr. Ghulam Mustafa Chandio, Security Guard (BS-02), Public Servant, and he has failed to show reasonable cause for not imposing a major/minor penalty under rule 4 of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973.

NOW THEREFORE, the Competent Authority i.e., I, Munawar Ali Mithani, Managing Director, Sindh TEVTA, Karachi is being authorized Officer do hereby impose a major penalty of **“DISMISSAL FROM SERVICES”** under rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973 upon accused Mr. Ghulam Mustafa Chandio (Public Servant) S/O Bagh Ali Chandio, Security Guard (BS-02), Shaheed Benazirabad.
