2.	Average annual turnover of Rs.10.00 million during last three years. (Bank Certificate/Audit Reports be provided).
3.	NTN & Sales Tax Registration. (Copy of Certificates be provided).
4.	Affidavit of firm that it is not blacklisted.
5.	Annual Income Tax Returns for last three years.
6.	Detailed Specification/Broachers, of quoted items.

Please Note: Samples shall be called from lowest three successful bidders/ firms.

- (The bids shall be evaluated and finalized on conformity of the samples by the Inspection committee)
- Sealed bids with necessary attachments accompanied by the Bid Security should be marked "**Procurement**" & **Tender Title**) and submitted at Sindh Technical Education & Vocational Training Authority, Street-19, Block-6, Gulshan-e-Iqbal, Near NIPA, Karachi, on the tender document submission date and time.
 - Bid opening procedure will be based on Single Stage –One Envelope Method. The envelope shall contain Technical Proposal & Financial Proposal along with complete material of specifications, company profile, NTN and GST Certificate of the company or any other information required in deemed necessary.
 - The bids will be opened on the aforementioned date & time in the presence of bidders or their authorized representatives.
 - The tender name and package (applied for) should clearly be written / marked on envelope.**
